2008-2009 SPECIAL EDUCATION TUITION CONTRACT AGREEMENT FOR THE UNION COUNTY SPECIAL NEEDS CAREERS ACADEMY

THIS AGREEMENT entered into this first day of July, 2008 between the Union County Educational Services Commission and the Springfield Board of Education, County of Union, State of New Jersey.

WHEREAS, the Springfield Board of Education lacks the necessary facilities for the provision of a suitable program for the 2008-2009 school year for certain classified students as provided for in the New Jersey Administrative Code Title 6 and Title 18A of the New Jersey Statutes, and;

WHEREAS, the Union County Educational Services Commission and the Union County Vocational Technical Schools have established suitable classes which provide a vocational education program for students classified as such and maintain the necessary facilities to engage in such an educational program,

NOW THEREFORE, in consideration of the premises and of the mutual premises and covenants herein contained, it is agreed by the parties hereto that:

- 1. The Union County Educational Services Commission in cooperation with the Union County Vocational Technical Schools shall provide a suitable shared time educational program in accordance with procedure and regulations established by the New Jersey Commissioner of Education and the New Jersey State Board of Education, for those classified students who shall be referred to them by the Springfield Board of Education;
- 2. The Springfield Board of Education, as consideration for such a shared time vocational education program shall pay a tuition of \$11,950. for the 2008-2009 school year. The school year will be that established by the Union County Educational Services Commission and the Union County Vocational Technical Schools. Annual tuition shall be prorated commencing with the calendar month of enrollment. One tenth of the annual tuition shall be payable monthly commencing on the 30th day of each month for which services have already been rendered for said month or any part thereof.
- 3. If any student is in attendance in the Union County Special Needs Careers Academy for any portion of a month, or though not in attendance, is enrolled and thirty (30) days notice, in writing, of withdrawal has not been given the Superintendent of Union County Educational Services Commission, the Springfield Board of Education shall be liable for a full month's tuition as aforesaid. Withdrawal of a child during the month without said thirty (30) days notice shall immediately terminate this contract as to said student with tuition payable through the month, or two weeks following the date of withdrawal, whichever is greater.
- 4. If, in the opinion of the professional consultants associated with the Union County Educational Services Commission and the Union County Vocational Technical Schools, a student is affected with syndromes of retractory nature arresting his/her educational and social adjustment, or for any other reason, the student shall be dismissed after ten (10) days notice, in writing, has been given the Superintendent of the Springfield Board of Education and thereupon this contract shall immediately terminate as to such student.
- 5. The students shall arrive at and depart from the premises of the Union County Special Needs Careers Academy at such times that it establishes. The Union County Educational Services Commission or the Union County Vocational Technical Schools shall have no responsibility for transporting any students to and/or from the premises of the Union County Special Needs Careers Academy unless under a separate agreement.
 - 6. Progress Reports shall be provided semi-annually.
